



RECOMMENDATION

Adopt Resolution 2017-033 amending the 2016-17 adopted budget appropriating \$10,633 in the General Fund to provide additional After School services for the 2016-17 school year at Washington School Site.

EXECUTIVE SUMMARY

The City of Reedley provides services for the after school program at Washington School site. Services that the City provides include hiring, training and supervision of personnel, payroll, budget management, reimbursement billing, coordination with the school principals, and providing a cell phone each the school site. City staff is amending the budget to reflect funds that will provide additional staff time to supervise field trips and additional staff prep time. An amendment was completed with Fresno County Office of Education. This action is to amend the City of Reedley budget to reflect the amended amount.

FISCAL IMPACT

This additional \$10,633 will increase the 2016-17 Fiscal Year budget amount for the Washington School Site to \$65,426.
