

RECOMMENDATION

It is recommended that the City Council approve the attached five-year services agreement with Blackboard Connect Inc. for a Public Communications and Messaging System.

EXECUTIVE SUMMARY

Since 2006, the City has used Blackboard Connect Inc. Connect-CTY service that allows City officials to send personalized voice messages to the entire City or targeted constituents in minutes. The system is used by almost all City departments for notifications such as: road work/closures, public hearings/workshops, council district meetings, disposal schedules, and neighborhood meetings. The system can also be used for emergency notifications. The City entered into a three year Services Agreement on July 27, 2009, and a subsequent four year agreement on September 25, 2012, of which this term has now ended as of July 31, 2016. The City paid for services covering this fiscal year (August 1, 2016 through July 31, 2017) based on the pricing from the last year of the previous contract, which was \$11,032.

Department staff were consulted and it was determined that the service still provides a valuable benefit to the community. City staff then contacted the company to attempt to negotiate new terms. The City asked for an adjustment to the annual price, and Blackboard Connect officials responded with a reduction from the current \$11,032 to \$8,274 annually. Based on the actual use of the service and competing services on the market, staff felt the pricing could still be improved, and Blackboard came back with a further reduction to a \$7,852.13 annual fee fixed for five years. At the end of the new five year term, the City may terminate the Agreement for convenience by giving Blackboard Connect at least 30 days notice prior to the end of the term, or annually thereafter.

Mobile 'App'

In addition to the telephone based communications and messaging system, the current software package the City is subscribed to includes a mobile device application that is free for the public to download. Staff

are currently reviewing the application for a possible rollout to the public later this year. Residents, business owners, and other community stakeholders can receive real-time City alerts on their mobile devices even if they do not receive the traditional phone call. The application allows the recipient to read and save the message at their convenience, instead of the possibility of not being available when the telephone call comes through, or if they do not have a traditional landline. The telephone notifications will continue alongside any utilization of the mobile application.

FISCAL IMPACT

The City will benefit from a \$3,179.87 annual cost savings for this service, for a total savings of \$15,899.35 over the next five years what would have been paid if the current pricing had continued on a year to year basis with no negotiation. Savings will be spread over various City departments and operating funds.

On September 25, 2012, the City Council approved a four year services agreement with Blackboard Connect, Inc.
