AMENDMENT I TO AGREEMENT

THIS AMENDMENT I TO AGREEMENT, hereinafter referred to as Amendment I, is made this 21st day of August, 2018, by and between the COUNTY OF FRESNO, a political subdivision of the State of California, hereinafter referred to as the "County", and the CITY OF REEDLEY, hereinafter referred to as the "City".

WITNESSETH

WHEREAS, the County has been designated as the sponsoring agency to administer and implement the Community Development Block Grant (CDBG) Program activities of the County, and its participating cities, in accordance with the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and the laws of the State of California; and

WHEREAS, on March 6, 2018, the County and the City entered into Agreement 18-071, hereinafter referred to as the "Agreement", whereby \$241,730 in CDBG funds were made available to the City for the Reedley City Street Improvements, Phase VIII, Project No. 17571, hereinafter referred to as the "Project"; and

WHEREAS, the City now has an additional \$92,859 from its allocation of CDBG funds that may be made available to the Project to reduce the City's local fund commitment under the Agreement; and

WHEREAS, the City has requested these additional CDBG funds in the amount of \$92,859 be made available to the Project for the purposes of this Agreement.

NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the City and the County agree to amend the Agreement as follows:

- 1. That the text on Page 1, Lines 14 through 19 be amended to read:

"WHEREAS, the total cost of the Project is estimated at \$775,650 and the City has committed local funds to the Project in the amount of \$441,061 and is in need of \$334,589 in CDBG funding to complete the Project; and

WHEREAS, the County can make available \$334,589 in CDBG funds needed for the Project from the City's 2018-2019 CDBG allocation (\$92,859), from the City's 2017-2018 CDBG allocation (\$224,231), and from the City's remaining balance of CDBG funds (\$17,499); and"

1 2. That the proposed funding summary on Page 3, Lines 3 and 4 be amended to read:

4		Total	\$775,650"

5 3. That the dollar figure set forth on Page 2, Line 28, Page 3, Line 16, and Page 4,
6 Line 18, be amended in each such place to read "\$334,589".

7 All remaining provisions, terms, covenants, conditions, and promises contained in said
8 Agreement, dated March 6, 2018, shall remain in full force and effect.





RECOMMENDATION

Staff recommends that the City Council take the following action:

Adopt Resolution No. 2018-065 authorizing the execution of Amendment No. 1 to City-County Agreement 18-071 for CDBG Project No. 17571.

BACKGROUND

On January 9, 2018 the City and County entered into Agreement 18-071 for Reedley Street Improvements Project (Phase VIII) Project No. 17571 (Project) for the reconstruction on Dinuba Avenue from Southern Pacific Railroad to East Avenue and East Avenue from Dinuba to Lincoln Avenue, whereby \$241,730 in CDBG allocated funds were made available to fund this project. The project total is \$775,650, whereby \$533,920 was to be provided by the City. The local funds will come from a variety of sources including Measure C, Vehicle Impact Fees, Development Impact Fee and water/wastewater Enterprise Funds.

As a result of CDBG surplus funds released from the CDBG Project 18571, an additional \$92,859 is available to be allocated to the Project which will reduce the City's contribution of local funds.

Amendment No. 1 to Agreement 18-071 will revise the CDBG funds from \$241,730 to \$334,589, reducing the local financial contribution amount. The proposed funding summary in the City-County Agreement for CDBG Project No. 17571 has been amended as follows:

FISCAL IMPACT

Approval of Amendment 1 to Agreement 18-071 will appropriate an additional \$92,859 for a total of \$334,589 to fund design and construction expenses for the Project and reduce the City's local fund contribution.

PRIOR COUNCIL ACTIONS

On September 27, 2016 City Council approved Resolution No. 2016-082 designating CDBG 17571, Reedley City Street Improvements (Phase VIII) as the 2017-2018 CDBG Project. The resolution also authorized the City Engineer to submit CDBG 17571, Reedley City Street Improvements (Phase VIII) project application to Fresno County for CDBG funding in Program Year 2017-2018. On January 9, 2018, the City Council approved Resolution No. 2018-003 authorizing the execution of the City-County Agreement for CDBG Project No. 17571.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REEDLEY AUTHORIZING THE EXECUTION OF AMENDMENT No. 1 TO CITY-COUNTY AGREEMENT 18-071 FOR CDBG PROJECT No. 17571, REEDLEY CITY STREET IMPROVEMENTS (PHASE VIII), RECONSTRUCTION ON DINUBA AVENUE FROM SOUTHERN PACIFIC RAILROAD TO EAST AVENUE AND EAST AVENUE FROM DINUBA TO LINCOLN AVENUE

WHEREAS, the County of Fresno has been designated as the sponsoring agency to administer and implement the program for the Community Development Block Grant (CDBG) activities of the County, and its participating cities, including the City of Reedley; and

WHEREAS, the City of Reedley wishes to enter into an Agreement 1 to Agreement 08-071 with the County of Fresno allocating the funds for the City's 2017-2018 CDBG allocation to the Reedley City Street Improvements (Phase VIII), CDBG Project No. 17571; and

WHEREAS, the County of Fresno has determined that \$92,859 in additional funds from the CDBG Project No. 18571 are currently available to the City of Reedley for said project and the City of Reedley has requested that these funds be allocated to fund the CDBG Project No. 17571 for a total CDBG allocation of \$334,589;

NOW, THEREFORE BE IT RESOLVED that the City of Reedley, City Council, using their independent judgment approve Resolution No. 2018-065 based on the following:

1. The above recitals are true and correct; and
2. The City Council finds the Amendment 1 to Agreement 18-071 for CDBG Project No. 17571 is consistent with the CDBG program; and
3. The City of Reedley City Manager is hereby authorized to execute Amendment 1 to the City-County Agreement 18-071 for the Reedley City Street Improvements (Phase VIII), CDBG Project No. 17571.
4. This resolution is effective immediately upon adoption.
