FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This First Amendment to Professional Services Agreement ("First Amendment") is made and entered into effective on August ____, 2018 ("Effective Date of First Amendment"), by and between the City of Reedley, a municipal corporation ("City") and NV5, Inc., a California corporation ("Consultant").

RECITALS

WHEREAS, City and Consultant entered into that certain Professional Services Agreement dated August 14, 2017 ("Agreement"), the terms of which are incorporated herein by this reference; and

WHEREAS, City and Consultant mutually desire to extend the term of the Agreement by two (2) years as set forth in this First Amendment.

NOW, THEREFORE, in consideration of the above recitals and their mutual promises, and other valuable consideration, the sufficiency of which is hereby acknowledged, City and Consultant agree as follows.

AGREEMENT

- 1. Recitals. The recitals stated above are true and correct and are a substantive part of this First Amendment.
- 2. Amendment to Section II of Agreement. Section II of the Agreement is hereby amended to provide for an extension of the term of the Agreement for two (2) years, from August 14, 2018 through August 14, 2020.
- 3. <u>Increase Agreement Budget.</u> Increase agreement amount by 400,000.00 for contracted services.
- 4. All Other Terms Remain in Effect. Except as expressly set forth herein, all other terms of the Agreement shall remain unchanged and in full force and effect, including all capitalized terms defined in the Agreement unless otherwise defined in this First Amendment, and the Agreement shall be interpreted so as to give full force and effect to this First Amendment.



RECOMMENDATION

Approve and authorize the City Manager to execute an Amendment No. 1 to Professional Services Agreement with NV5, Inc. entered into on August 14, 2017 and extend the contract two years to August 14, 2020 and increase the compensation by \$400,000.

EXECUTIVE SUMMARY

After issuing a request for proposal and interviewing several firms, the City selected NV5, Inc. (Consultant) to perform professional services agreement for construction management services on August 14, 2017.

Since that time, the Consultant has performed services to the City on several projects as well as assisting in responding to general questions or issues that have occurred during the life of the contract. Staff has been pleased with the Consultant's assistance and services, and feels there is a benefit to the City to continue the relationship as the initial contract nears the end of the agreement term.

As there are several roadway projects that are planned to begin design and construction over the next two years and will require extensive construction management professional services, staff is requesting that the term of the Consultants agreement be extended two years to conclude on August 14, 2020 and compensation be increased to cover costs up to \$400,000.

FISCAL IMPACT

There is no fiscal impact to the General Fund as all work performed by the Consultant is performed on a task order basis for each individual project. The Consultants work is done on a task order basis on federal aid contracts or other grant projects which are eligible for reimbursement. Any work not eligible for reimbursement will be covered the either by Measure C or other grant funds.
