RECOMMENDATION

That the City Council approve and authorize the City Manager to execute a purchase agreement for a Restorative Justice Database titled "Outcome Tracker", through the vendor Vista Share L.L.C.

EXECUTIVE SUMMARY

The Reedley Police Department, in partnership with Kings Canyon Unified School District (KCUSD), Mennonite Central Committee (MCC) and Community Youth Ministries (CYM) has been accepting and mediating criminal cases through the Reedley Peace Building Initiative (RPBI) since its inception in 2011. Over the course of seven years, RPBI has mediated in excess of 360 cases with over 400 offenders. The current method of collecting and tracking case information is an ongoing spreadsheet that contains all applicable data.

The current spreadsheet method of record keeping and case tracking has become cumbersome and it does not allow for any comprehensive statistics to be produced, without a great deal of time and calculation. A robust database system would provide an opportunity for satisfaction surveys, long term follow-up, and mediator interaction with specific individuals and cases through a web based platform.

BACKGROUND

The Reedley Peace Building Initiative partners have seen a need for a more comprehensive and secure platform for case management and follow-up tracking. The volume of criminal RPBI mediation data that is currently being kept through spreadsheets has continued to increase to an unmanageable size. Although the Reedley Police Department is legally responsible for housing and maintaining all criminal case data, Jake Harder (MCC), the RPBI Director and Jennifer Jantzen (CYM), the RPBI Case Manager handle a majority of the data input, case notes and contract completion information. Lieutenant Marc Ediger has primarily been responsible over the past 5-7 years for combining some of the data to produce statistics for outside agency presentations and to accompany grant applications aimed at Restorative Justice.

RPBI Director Jake Harder has consulted with multiple companies who provide platform databases and hosted cloud storage that would also adequately support a Restorative Justice caseload. As a result of the consults, two products were presented to the RPBI partners for evaluation. "Outcome Tracker" through Vista Share LLC and "My RJ" through Ivstitia Limited were evaluated based on cost, customization, data capabilities and cloud security.

After evaluation, the RPBI partner group agreed "Outcome Tracker" was the more robust database system that would currently meet the needs of the RPBI caseload and provide expansion for future cases, mediator interaction, a wide variety of data collection categories, participant feedback, text messaging notification and long term follow-up options. Multiple user licenses will allow for six (6) RPBI administrative staff to have full access and also include nine (9) licenses for trained mediators to have direct access to case narratives, notes, contract agreements and future follow-up needs.

FISCAL IMPACT

Currently the RPBI partners have agreed to set aside \$13,600 from the General Fund RPBI account for the current fiscal year 2017-2018. This surplus amount will fully fund the 2018-2019 and 2019-2020 fiscal year system and maintenance costs without any additional 2018-2020 funds being expended.
