This agreement subject to the terms and conditions hereof, is entered into between 'Wild Water Adventure Park' located at 11413 E. Shaw Ave., Clovis, CA and City of Reedly , herein referred to as 'Group'.

PRICES & FEES: Wild Water Adventure Park (WWAP) agrees to lease to Group and Group agrees to pay the fees for the uses of the group area(s), located at Wild Water Adventure Park. The Fees will be based on the headcount, the package type, and any services or special items that are provided for the group event. The date of the event shall be the Event Date listed above. The ticket price includes the above listed items and is based upon the contract prices listed, provided a signed contract and deposit is received by the expiration date printed above. Occasional promotions may offer discounted individual gate ticket prices below group rates. Promotional prices are NOT valid for Group Events. The Pavilion kitchen has an additional usage fee of \$75.

DEPOSITS: The Group shall, upon signing of this Agreement, pay to Wild Water Adventure Park, a reservation deposit. Upon receipt of said deposit, the Group reservation shall be confirmed. DEPOSITS ARE NON-REFUNDABLE.

TICKETS/WRISTBANDS: After the deposit has been paid prior to the date of the event, tickets/wristbands shall be issued under consignment to the undersigned individual, his/her agent, or another duly authorized agent of the Group. Distribution of tickets to to group members is the responsibility of the Group. No Group tickets may be sold on park premises. Group tickets and the above ticket price are valid for the date of the event only. The Group will be charged for each admission on the day of the event.

FOOD & BEVERAGE: If the Group is to be catered, a FOOD & BEVERAGE GUARANTEE must be submitted to WWAP TEN (10) days prior to the event. It is understood that the Group may bring its own food, but no outside catering will be allowed on Wild Water Adventure Park property. No alcoholic beverages may be brought into the park. All beverages supplied by the Group must be in a metal or plastic containerand no glass containers of any kind are permitted in the park. No dispensed beverages from tappers or boxes such as softdrinks or kegs of beer can be brought into Wild Water Adventure Park.

VEHICLES: Any Group items to be trammed into the park must be SCHEDULED AND CONFIRMED with Group Sales PRIOR to the day of the event. It is understood by the Group that no vehicles are permitted within the Park.

No amplified music or DJs can be brought into the park without prior written consent from Wild Water Adventure Park ownership.

BILLING: Unless special billing arrangements are made in advance, the event must be paid no later than 10 days prior to the event. Any unpaid balance will be charged an interest fee at the rate of 1.5% per month. After 30 days from the event collection procedures will be instituted. It is the responsibility of the Group to leave its area(s) reasonably clean and tidy and orderly. In the event the Group fails to leave area(s) in such condition, the Group hereby agrees to reimburse Wild Water Adventure Park an additional \$100 for the Pavilion and \$75 per additional group area.

Special Instructions:
-YOU WILL ONLY BE SENT THE AMOUNT OF TICKETS FOR YOUR FINAL STUDENT & CHAPERONE HEADCOUNT GIVEN AT YOUR 10 DAY CONFIRMATION. NO EXTRAS WILL BE PROVIDED.

-ANY TICKETS THAT ARE NOT RETURNED WILL BE CHARGED TO YOUR INVOICE.

-A MEAL/BEV HEADCOUNT GUARANTEE IS REQUIRED AT YOUR 10 DAY CONFIRMATION.

This Agreement allows all Group members the full use and enjoyment of all Wild Water Adventure Park facilities at no additional charge except for concessions or merchandise members may wish to purchase. The Group shall monitor and be responsible for the behavior of its members. In no event shall Wild Water Adventure Park be liable for accidents or injuries that should occur to a Group member from an activity organized or sponsored by the Group or some of the members or should an accident occur to a member not complying with Wild Water Adventure Park rules. The group shall indemnify and hold harmless Wild Water Adventure Park for such accidents and injuries. Should an action be taken to enforce any part of this Agreement, the prevailing party shall be entitled to be reimbursed for its attorney's fees.
